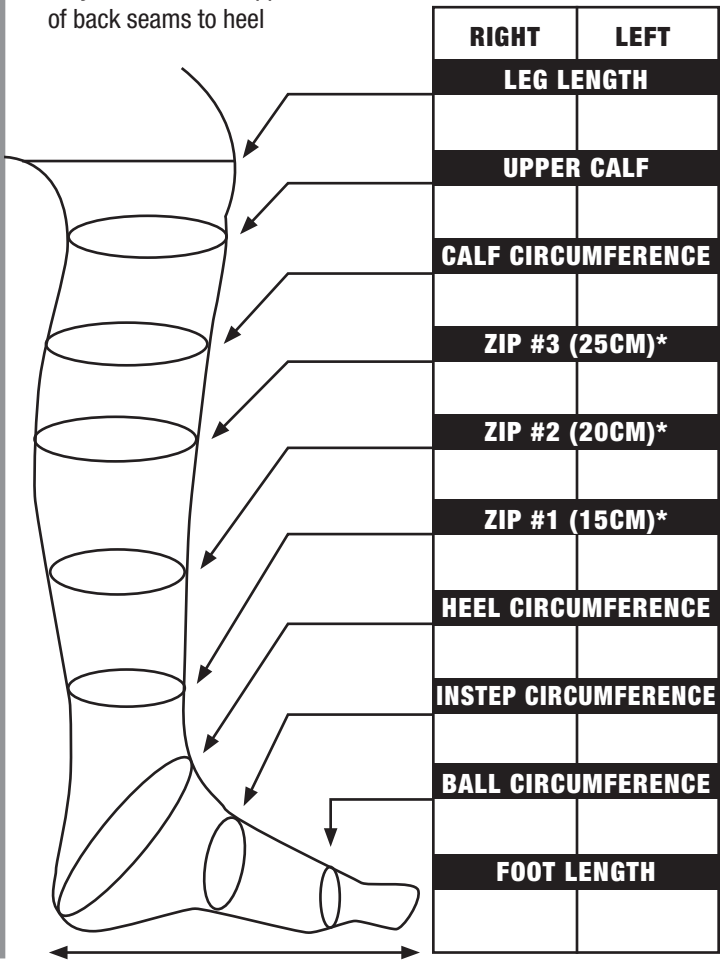

Client shall pay all local, state and/or federal taxes applicable in the purchase of products from Dressage Connection. Dressage Connection ships orders to clients using UPS. You will be contacted with a tracking number once your order is ready for shipping. Client should take care and refer to instructions for proper care and handling of the product when using, cleaning, handling and storing the product to prevent damage to it. Client accepts these terms and conditions as the entire agreement that exists between client and seller with respect to each specific purchase order. These terms and conditions of sale may not be amended, changed or modified in any way except in written instrument duly executed by both parties. Should any item supplied be other than specified or agreed in the final order acknowledgment, the client must notify Dressage Connection immediately in writing. Dressage Connection will use its commercially reasonable efforts to provide the goods as proposed in the final order acknowledgment. Absolutely no back charges will be considered if Dressage Connection is not allowed to first correct any inaccuracies. Any disputes arising out of this Agreement shall be submitted to binding arbitration before the Joint Ethics Committee or a mutually agreed upon arbitrator pursuant to the rules of the American Arbitration Association. The Arbitrator's award shall be final, and judgment may be entered upon it in any court having jurisdiction thereof.
